Guidelines

- Artists are invited to make application for consideration. Applicants will submit 3 photos of their work and 1 of their booth. Artist participation is by invitation. A selection panel will identify artists to be invited. Decision of the panel will be final. Maximum 2 artists per booth. If two artisans will occupy a booth, both must make individual application, complete with separate images.
- Art exhibited/sold at festival will be only original work created by the exhibitor. No kit work permitted. No buy/sell.
- Artists will be assigned a 10x10 space on the festival grounds. Artists must have a tent and will provide their own tents, tables, chairs, etc., and all items and art must remain within the assigned space. Exhibitors are responsible for removing all trash from their booth area at the close of the festival.
- Set-up will begin at 8:00 a.m. Artists are asked to unload, remove their vehicles, then return to set up. All vehicles must be removed from festival area by 9:15 a.m. Artists will be ready to greet customers by 9:45 a.m. and booths will remain set up and operating until at least 5:00 p.m. – **there will be no early tear down.**
- Participating artists are responsible for collecting and submitting all required taxes. Barrow county currently collects 7% sales tax.
- This is a rain or shine event. No refunds will be given.
- Booth Fee: \$40 for GPAC members. \$50 for non-GPAC members. Electricity is not available.
- **Early Bird Booth Fee**, if application postmarked February 1st or prior: \$35 for GPAC Members and \$45 for non-GPAC members.
- Application Deadline: All entries must be postmarked by March 1, 2012 or earlier. Invitations will be sent within 10 days. Late applications considered only if space permits. Incomplete applications cannot be considered.
